

G ifts, memorials and bequests to the Friends of Arrow Rock's endowment fund are an especially thoughtful and long-lasting way to support the Friends' mission of historic preservation and education. In 2013, income from the endowment provided over \$38,000 of our income of \$246,000. The endowment is made up of five named endowment funds and one undesignated fund. For investment purposes, these funds are pooled and the pooled fund is divided between investment accounts that are professionally managed by the trust departments of Wood & Huston Bank in Marshall, Missouri, and Bank of America in Kansas City, Missouri. Named endowment funds may have either unrestricted or restricted uses. Of the five named endowment funds, their donors have restricted three to specific uses.

Named endowment funds may be established with a gift or bequest of \$50,000 or more. This is an ideal way to honor or memorialize a family member, or to provide a permanent source of income for one of the Friends' programs or activities that appeal to you. Friends Receive Gifts from Life Members, Foundations & Trusts

"I'm continually amazed by and grateful for the generosity of our many friends," says Executive Director Kathy Borgman. "It truly makes opening the mail and answering the phone and e-mails a delight. Working together, we get a lot done. Thank you so much!"

Here are some of the generous gifts received in 2013 in addition to the many who made membership and endof-year gifts that are listed elsewhere in this report.

Byron and Marilyn Shutz made a \$20,000 pledge and first payment to fund the writing and publishing of the history of the Friends of Arrow Rock which will be released at our 55th Annual Meeting June 8, 2014.

Kathy Diggs made a \$2,265 gift to enable us to upgrade our insurance to full replacement coverage. We currently carry more than \$2 million dollars of insurance coverage on our 13 historic properties.

The Dess Caylor Trust, George Blackwood,

Trustee, provided a \$2,500 grant for a communications consultant to manage our web site, write e-newsletters and make regular posts to Facebook.

Following his tradition, **John Callison** designated a \$1,000 Christmas gift in his honor to be given to the Friends. Wicky Sleight gave her husband an "adopted building" for a Christmas gift; he now is helping watch over the John P. Sites House, and the \$1,000 gift is taking care of lots of utility bills.

Bill True made a \$5,000 gift that allowed us to install an alarm system in the new African-American Museum in the Black Lodge and to upgrade the system in the Sappington Museum. Both museums are open daily year round. And there was even some money left over to cover utility costs.

The **Enid and Crosby Kemper Charitable Trust, UMB, Trustee** made a \$5,000 gift to the general operating fund. Unrestricted funds are so helpful in meeting the day-to-day costs of keeping the doors open, funding everything from salaries to utilities.

Tom and Margaret Hall's generous gifts included extending their annual 50th Anniversary Campaign Pledge of \$20,000 to fund a development and management consultant, a \$3,000 gift to cover the cost of distributing the planned 55th anniversary history of the Friends of Arrow Rock to everyone on the Friends' mailing list, a 37" flat screen TV in the museum shop for viewing *The* Preservation Story of Arrow Rock, produced by Communications Consultant Sandy Selby, a \$1,000 gift for computer consultation and troubleshooting, a \$500 gift for a higher level of membership of the Friends in the

State Historical Society of Missouri, professionally photographed images of several Bingham portraits, \$2,000 for electrical work at the Sappington Museum, and \$450 for signage and a reproduction of Bingham's *Family Life on the Frontier* for the Shelby Log Cabin.

Friends Trustee Dan Auman, co-owner of Auman Mack, a marketing, advertising and design firm in Mission, Kansas, along with his colleague Karen Swope, donated numerous services to the Friends in 2013. For the second year in a row, Dan's design of our newsletter won the prestigious first place "Philly" award in the print newsletter category at the annual Philanthropy Midwest Conference in Kansas City. His design of our 2012 Christmas Party Invitation also took first place in the Invitations category. In addition to these award-winning projects, he designed way-finding signs for all our properties incorporating a new logo which Dan designed. And the Friends have new stationery to match. Thanks to Dan and his associate Karen Swope, we are enjoying a new look, with professional "branding" of all of our publications and signage.

Printing and hardware for the way-finding signs were funded by a generous gift from **Mrs. Althea Breitwieser**, mother of Friends Trustee **Chet Breitwieser**, in memory of Chet's father and brother. The **Gladys M. Thomas Ability Fund**, a donor endowment under the auspices of the Able Trust, Tallahassee, Florida, made its annual distribution of \$2,747 in 2013. Funds are used for the upkeep of the 1903 Lawless House, which Gladys restored in 2003. The house was her grandparent's home.



Jeffris Family Foundation Challenge Grant



 Missouri Humanities Council (MHC) awarded \$5,000 grant to support FAR project "The African - American Experience in Arrow Rock."


- FAR introduced an African-American component funded by MHC, with support from the National Endowment for the Humanities.
