his quote struck me as especially appropriate for the Friends of Arrow Rock when I recently read it in a publication of the Virginia Historical Society (VHS), one of the oldest and largest state historical societies in the country. The Friends have benefited a great deal over the years from information, advice, and support from leading history-related organizations such as the VHS, from our own outstanding State Historical Society of Missouri in Columbia, the Missouri History Museum in St. Louis, the Colonial Williamsburg Foundation in Williamsburg, Virginia, the National Trust for Historic Preservation in Washington, D.C., and other organizations who, although much larger, have goals and missions similar to the work of the Friends.

When the Friends of Arrow Rock was founded in 1959, the town of Arrow Rock was largely in an advanced state of decay, aside from a few private homes and the buildings in the Arrow Rock State Park (now the Arrow Rock State Historic Site). Our mission was simply to prevent further deterioration of as many of the buildings as possible. Thanks to a lot of hard work and generous support over the past 54 years, the 13 buildings owned by the Friends have been preserved and restored, and private property owners have been inspired to save most of the others. Historic preservation was our first, and still our primary, effort.


Once the buildings had been restored, generous donors made gifts to the Friends of valuable antique furniture, works of art, antique firearms, archaeological artifacts, and many other items related to the history of Arrow Rock and the Boonslick district of central Missouri. Starting in the 1960s, this naturally led to the expansion of the Friends' efforts from historic preservation into use of many of the restored buildings as museums. The Friends have benefited from two consultations with the American Association of Museums through their Museum Assessment Program, and in many ways we now function as a history museum.

During the 1970s, the Friends' educational programs began as a way to make better use of the restored buildings and the unique museum collections.

Our educational efforts expanded dramatically under the leadership of our first professional staff members in the 1980s and 1990s. Now thousands of students of all ages take part every year in the educational programs of the Friends. There is no doubt that the Friends of Arrow Rock is now one of the leading history education organizations in Missouri.

Also starting in the 1970s, the Friends began to issue reprints of several out-of-print historic books about the Arrow Rock area. We were directly or indirectly responsible for several new publications about Arrow Rock during the 1980s and 1990s, including original historical articles published in the Friends' newsletter. In the last ten years, the Friends have published or co-published full-length books such as Michael Dickey's award-winning *Arrow Rock, Crossroads of the Missouri Frontier* and a complete collection of the letters of Arrow Rock's favorite son, artist George Caleb Bingham, co-published with the State Historical Society of Missouri in 2011 as "*But I Forget That I Am a Painter and Not a Politician*": *The Letters of George Caleb Bingham*. With the generous support of the Pillsbury Foundation of Frontenac, Missouri, the Friends are now about to undertake the production of a full-length documentary on the life and art of George Caleb Bingham. Thus the Friends have developed into a historical research and publication organization.

So it is hard to say if the Friends of Arrow Rock are a historic preservation organization, a history museum, a kind of school of history, or a full-fledged historical society. We have some of the aspects of all of these, although we clearly have more work to do to reach our goals in any of these areas. Perhaps it is easiest to sum up our work with the quote with which I began: "We are in the remembering business."

There is a lot of important history to remember in Arrow Rock, and we hope that you will help us in our work of preserving, recording, and sharing it. We encourage you to join the Friends at any of the levels you will find listed in the membership rolls as you review this report, and please come to see us often. We promise you that you will long remember your visit to Arrow Rock, and that your friendship for this special place will not be forgotten. Thank you for being a Friend! 

Endowment Gift Honors Janette Bohlken Crumpacker

→ *The Friends of Arrow Rock have received a very generous gift of \$50,000 to establish the Janette Louise Bohlken Crumpacker Memorial Fund.*

This permanent endowment fund is a gift of Mr. Joe D. Crumpacker of Nashville, Tennessee, to honor the memory of his beloved wife Janette, who grew up near Arrow Rock. Annual income from the Memorial Fund will be used by the Friends of Arrow Rock to establish and maintain an annual history-education and interpretation program.



Executive Director Kathy Borgman stresses the importance of the income that will be provided by this fund, because Arrow Rock has such an abundance of historic themes—the Missouri and Osage Indians, Lewis & Clark, the fur trade, the War of 1812, the Santa Fe Trail, westward expansion, frontier medicine, the Civil War, Missouri governors, the artistry of George Caleb Bingham, and African-American life—to name just a few! The wealth of history here is wonderful, but it also poses some interesting challenges.

“You can learn about all aspects of 19th century Missouri here in Arrow Rock, but you can’t do it all in one visit or one tour,” Kathy explains. “This endowment will enable us to develop our annual themes so that our knowledge will continue to grow and we will gain a new appreciation for the many things we can learn from our past, and in turn convey this history to many of Arrow Rock’s ca. 125,000 annual visitors.”

The 2013 theme will focus on 19th century medicine, a time when deadly cholera and malaria (called the “shakin’ ague”) caused untold hardship and death for many 19th century settlers. Doctors of the day were ill equipped to fight these little understood diseases, and practices like “purging, puking, & bleeding” were widely accepted. Arrow Rock’s own Dr. John Sappington recognized the

Operations Management, and Communications. This completed their 50th Anniversary Capital Campaign pledge. They contributed gifts providing for intern housing, and for “adopting” the Sappington Museum, which provided funds for the new entryway, and they donated two original copies of Dr. Sappington’s book *On the Theory and Treatment of Fevers*. The Halls also sponsored memberships in Nonprofit Connect, a Kansas City organization that provides education, resources, and networking for area non-

profits, and in the Colonial Williamsburg Foundation.

limitations and even dangers of such methods. Learning of the success of treating fevers in Europe with “the essence of the bark,” which we now know as quinine, Dr. Sappington mass-produced and marketed this first “wonder drug,” quinine, in the form of “Sappington’s Anti-Fever Pills.”

These anti-fever pills were instrumental in the settlement of the Missouri River Valley and were carried west by Santa Fe traders. In 1844, Dr. Sappington published a book in Arrow Rock, *On the Theory and Treatment of Fevers*, which is believed to be the first medical book written west of the Mississippi. This year, income from the Janette Louise Bohlken Crumpacker Memorial Fund will help defray the costs of developing programs and associated materials to tell this and other fascinating stories of 19th century medicine to school groups and on guided tours.


Janette Bohlken was born in Saline County and graduated from Slater High School. Her father Francis worked for a subcontractor who did work for the Corps of Engineers in helping to stabilize the Missouri River banks during the 1930s and 1940s.

She met Joe Crumpacker at the University of Missouri in 1951; they were married in 1953. After graduation from MU they moved away from Missouri, but the Arrow Rock area always held a special place in her heart. Local residents who remember Janette recall that she was very faithful in returning to visit her mother Eula who continued to live in the area and that she always liked to shop for unique gifts for Christmas

and other occasions in Arrow Rock. Janette was also an avid genealogist, which helped to spark her interest in local history.

Noting their frequent visits to Arrow Rock, Joe Crumpacker said there was a time years ago—before most of the historic preservation efforts occurred—when he was concerned about the fate of the village. In a recent call to Mr. Crumpacker, he expressed relief that Arrow Rock had escaped the fate of many other small Missouri towns: “It is surely wonderful that Arrow Rock did make it,” he said.

Janette died on August 13, 2011, leaving behind her husband and four daughters and their families, including seven grandchildren. Joe established the endowment fund to honor Janette and to support the work of the Friends of Arrow Rock in preserving the history of the place that meant so much to her. Janette and Joe Crumpacker had been married for 58 years at the time of her death.

“The Friends of Arrow Rock are extremely grateful to receive this most generous endowment gift in memory of Janette Bohlken Crumpacker,” said Friends of Arrow Rock President Tom Hall. “It not only honors her in perpetuity, it is also a permanent source of funds that we can count on to carry out the mission of the Friends of Arrow Rock. Our sincere thanks go to Mr. Joe Crumpacker for his very thoughtful and appropriate gift in memory of Mrs. Crumpacker. She will be gratefully remembered in Arrow Rock.”

was the Missouri Press Association’s Executive Director for 37 years. This is a matching gift for the Jeffris Construction Grant that will fund preservation work on the I.O.O.F. Lodge Hall that houses the Missouri Press Association Newspaper Press Museum. In addition, the **Missouri Press Foundation** made a \$2,000 matching gift for this project.

– Life Member **Althea Breitwieser** gave a \$3,000 gift in memory of her husband, Charles F. Breitwieser, and her son Todd D. Breitwieser. The gift will be used for new wayfinding signs at Friends

of Arrow Rock properties.

– The **Gladys M. Thomas Ability Fund**, a donor endowment under the auspices of the Able Trust, Tallahassee, Florida, made its annual distribution to the Friends, which was \$2,655 in 2012. Mrs. Thomas funded the restoration of the 1903 Lawless House, her grandparents’ home.

– **The Byron Christopher Shutz Historic Preservation Fund**, a donor-advised fund at the Greater Kansas City Community Foundation, provided \$2,037 in 2012. Income from this fund is received annually to support

the preservation of the Christopher Collection of Early Missouri Firearms and the John P. Sites Jr. Gun Shop.

Jeffris Challenge Grant Offers ‘Rare Opportunity’

The Jeffris Family Foundation has awarded the Friends of Arrow Rock a \$230,000 Challenge Grant for work on four of the Friends’ most historically significant properties: the John P. Sites Jr. House and Gunsmith Shop, the Masonic Lodge and the Independent Order of Odd Fellows Lodge.

The grant is contingent on raising a local match of \$460,000 over the next two-and-a-half years, so the Friends are busily at work seeking funding. To date, \$89,411 has been received or committed.

The specific projects to be completed are based on the recommendations contained in four professional Historic Structure Reports (HSR’s), which the Friends commissioned in 2011. These detailed reports identified structural, mechanical and preservation needs for the buildings, as well as an opportunity for adaptive reuse of the second floor of the Masonic Lodge as a modern meeting room. The Historic Structure Reports were supported by the Jeffris Heartland Fund administered by the National Trust for Historic Preservation; the William T. Kemper Foundation, Commerce Bank Trustee; the Board of Governors of the Miller Gift; and proceeds from the 50th Anniversary Campaign.

“We are grateful to the Jeffris Family Foundation for their commitment to preservation in rural midwestern communities such as Arrow Rock,” said Friends of Arrow Rock President Tom Hall. “It offers us a rare opportunity to receive both professional advice and financial support to help us carry out the recommendations in the HSR’s.”

Gifts and bequests to the Friends of Arrow Rock's endowment fund are an especially thoughtful and long-lasting way to support the Friends' mission of historic preservation and education.

In 2012, income from the endowment provided over \$35,000 of our income of \$244,000. The endowment is made up of five named endowment funds and one undesignated fund. For investment purposes, these funds are pooled and the pooled fund is divided between investment accounts that are professionally managed by the trust departments of Wood & Huston Bank in Marshall, Missouri, and Bank of America in Kansas City, Missouri. Named endowment funds may have either unrestricted or restricted uses. Of the five named endowment funds, their donors have restricted three to specific uses.

Named endowment funds may be established with a gift or bequest of \$50,000 or more. This is an ideal way to honor or memorialize a family member, or to provide a permanent source of income for one of the Friends' programs or activities that appeals to you. The Future of the Arrow Rock Post Office By Postmaster Tempe McGlaughlin

After a year of closure discussions and speculation about the future of the Arrow Rock, Missouri, Post Office (and several thousand others around the country), the USPS has officially presented their plan.

Beginning in January 2013, many larger offices with Postmasters that took an early retirement package were left vulnerable. Hours were reduced or services were changed to rural delivery.

Because the Arrow Rock Postmaster did not retire, the Post Office will remain open eight hours a day until September 30, 2014. At that time she will be mandatorily retired. The office

will then come under the supervision of a larger office (Arrow Rock's home office will be Marshall, Missouri) and a clerk will be hired to run the Arrow Rock office.

The office will then be open either four (4) or two (2) hours a day, depending on revenue generated. Hopefully, the lobby will remain open for customers to retrieve their mail. There is also the possibility it may become a rural mail route, with a cluster box for deliveries.

Your response to our plea for help made a huge difference for Arrow Rock and all rural post offices around the country. It caused the Postal Service and

Government to recognize the importance of these individual Post Offices to their communities and each citizen's right to standardized and equal universal service. It was a great grass roots effort that brought results and is still being discussed in the legislature.

You can still help the Arrow Rock Post Office by continuing to order stamps. Revenue and volume are two significant measures that will determine future levels of service.

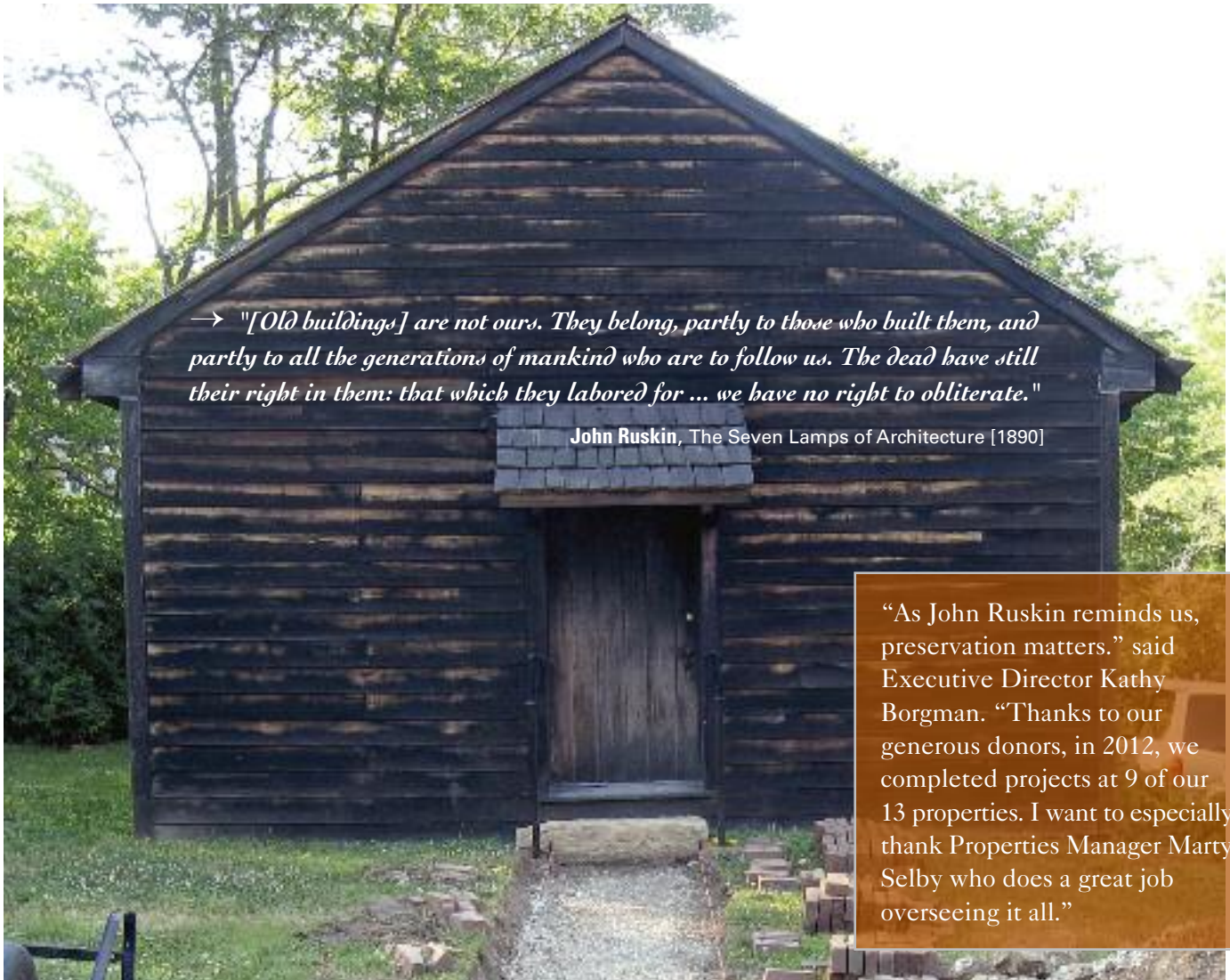

First Saturday Lecture Series

The popular First Saturday Lecture Series emphasized the Civil War in recognition of the sesquicentennial commemoration. The year opened with a talk by Dr. Joan Stack, curator of art collections for The State Historical Society of Missouri, followed by “The Civil War in Arrow Rock,” by Mike Dickey, Arrow Rock State Historic Site Administrator. New Black History Museum and Exhibit

June 2nd marked the opening of the Friends of Arrow Rock's new Black History Museum and Exhibition, “Reflections of African-American Arrow Rock: 1865-1960,” in the restored Brown Lodge #22. More than 200 people enjoyed lectures by scholars Tim Baumann and Gary Kremer held at the State Historic Site Visitors Center as well as viewing the exhibit. Teresa Habernal, Black History Committee member, shared memories of growing up in Arrow Rock. The event was the culmination of 20 years of effort to “give a voice” to a significant segment of Arrow Rock's population and their previously unheralded contributions to our history. Anna Mae Hodge, Trustee Emeritus of the Friends of Arrow Rock, has supported the project from its inception and her early paintings of African-American homes are featured in the exhibit.



We would like to thank all who gave of themselves in numerous ways to make this a success over the years, especially Nancy Finke, Friends Board member, and Pam Parsons, former Education Director, who curated the exhibit. The exhibit is open daily.

Civil War Encampment and Reenactment

Continuing our 2012 Civil War theme, an Encampment and Reenactment was held September 22nd, co-sponsored with the Arrow Rock State Historic Site. This living history-education event brought close to 250 visitors into town as both adults and children learned how the Civil War impacted Arrow Rock.

This year saw an increase of over 200 students compared to 2010; 21 schools and home schools attended, with a total of 950 students and 255 adults participating. 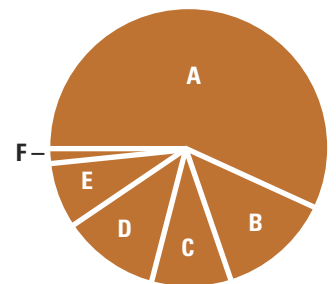

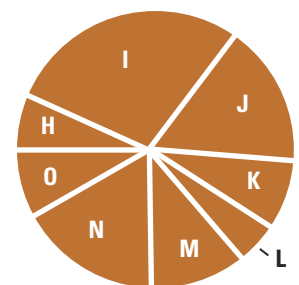
